It is noted that ethyl alcohol was fully eliminated from the process in 2015, and a TRA exit record was submitted with the 2016 SWIM report.

Acetone is no longer required to be reported under Ontario Regulation 455/09 (with the repeal of Ontario Regulation 127/01), effective January 1, 2020.

There has been a decrease in the amount of styrene entering the process and released to air due to a decrease in production levels for 2019. Polymeric resin waste containing styrene was shipped in 2019.

There are no plans to reduce styrene use.
